Status conference held. Petitioner appears by counsel, Joshua Neal and Respondent appears by counsel, Steven W. Krohne.


The Court finds that:

1. It is necessary for the parties to conduct discovery before a hearing can be scheduled.
2. The counsel present at this status conference agree to accept service of pleadings on behalf of all of their respective parties.
3. Petitioner's bond for the possible payment of lost fees, attorney fees and expenses is now set in the sum of twenty five thousand dollars (\$25,000.00), cash or corporate surety, payable to the Clerk of the LaGrange Circuit Court within fourteen (14) days, as per I.C. 36-9-23-26.1(c).
4. Parties are directed to submit Trial Briefs to the Court on or before January 20, 2010.
5. This case is set for bench trial on January 27, 2010 at 10:00 a.m. to and including 4:00 p.m. and also January 28, 2010 at 12:00 noon to and including 4:00 p.m.
6. Petitioner's Motion for Change of Judge is granted. The Court now appoints the Honorable Allen N. Wheat as Special Judge, subject to his acceptance, with the understanding that trial dates and bond amount is subject to review and possible modification by the Special Judge.
